Visitor Information

From US-29 (Reidsville and Danville areas)

Exit on Cone Blvd. Turn right. Follow Cone Blvd. until it crosses Battleground Avenue and becomes Benjamin Parkway. Follow Benjamin Parkway until it intersects with Green Valley Road. Turn left at the light. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From I-85 (Charlotte, High Point areas)

Take Exit 120 to Greensboro. Continue 2.4 miles to Exit 35B (the sign reads Coliseum area, 220 North, 40 West). Continue 1.9 miles until you pass through the stoplight at the intersection of Coliseum Blvd. Go a short distance and turn left at Lovett Street. Lovett becomes Aycock Street at Florida Street. Continue 1.2 miles (passing through the stoplight at the Lee Street intersection) until you reach Benjamin Parkway. Turn left onto Benjamin Parkway. Go approximately 1 mile and turn right onto Green Valley Road at the light. Continue straight down Green Valley



Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From I-85/40 (Raleigh, Burlington areas)

Take Exit 131 (the sign reads 40 West, Old Business 85 South, to Hwy. 70, Greensboro-Winston-Salem). Then take Exit 131 to Hwy. 70 and get onto 70 via Exit 44 (The Replacement, Ltd. building is on the right.) Proceed 2.1 miles on Hwy. 70. Bear right towards Greensboro onto Hwy. 70 West. Proceed 6.3 miles on Hwy. 70 West which becomes Wendover Avenue. Take Wendover Ave. heading West. Take the Battleground Avenue Exit (sign reads Roanoke, Battleground, 220 North). Go to the yield sign and get into the far left lane on Battleground Avenue. Proceed .5 miles on Battleground Avenue and turn left at the stoplight onto Green Valley Road. Pass through the next light at the intersection of Westover Terrace and Green Valley Road. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From I-40 (Winston-Salem)

Take the Highway 68/Airport exit. Turn left at the stoplight and proceed North to Bryan Blvd./Airport and bear right. Stay on Bryan Blvd. (which becomes Benjamin Parkway) for approximately 7 miles to Green Valley Road. Turn left at the light at the Green Valley and Benjamin Parkway intersection. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From Airport

Exit airport. Turn right onto Bryan Blvd. which becomes Benjamin Parkway. Proceed approximately 7 miles to the stoplight at Green Valley Road. Turn left at the light. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From US-220 (Madison, Martinsville, Roanoke areas)

US-220 becomes Battleground Avenue as you enter Greensboro. Turn right onto Benjamin Parkway just past Rice Toyota. Continue on Benjamin Parkway through 4 stoplights until you reach Green Valley Road. Turn left at the light. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From US-220 (Asheboro area)



Exit from US-220 onto I-85 South and take the next exit to the right (Holden Road). Turn right and proceed North on Holden Road for 4.2 miles to Wendover Avenue. Take Wendover East for 2.1 miles to Benjamin Parkway North exit. Cross over the bridge and turn right onto Green Valley Road at the light. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.

From Highway 421 (Sanford, Siler City areas)

Highway 421 becomes Martin Luther King Drive. Proceed to the intersection of Highway 29 North. Follow 29 North to Wendover Avenue West. Follow Wendover Avenue and exit at Benjamin Parkway North. Merge almost immediately right onto Green Valley Road. Continue straight down Green Valley Road, Turn right at the Lendew Ave. light into our parking lot at 800 Green Valley Road. We are located on the 5th floor, suite 500.
